CRT Default Decision and Order

The applicant(s) applied for small claims dispute resolution with the Civil Resolution Tribunal (CRT or tribunal) and requested a default decision and order of the tribunal. The following is the CRT's Default Decision and Order.

CRT DECISION

Proof of Notice:

- A respondent must respond to a Dispute Notice within 14 days of receiving the Dispute Notice, as indicated on the Dispute Response Form or as permitted by the CRT. A respondent served outside of British Columbia has 30 days to respond, instead of 14 days.
- 2. Based on the proof of notice form submitted by the applicant, I am satisfied that the respondent received the Dispute Notice and did not respond to it by the deadline set out in the CRT's rules.

Jurisdiction:

- 3. The CRT's small claims jurisdiction is set out under section 118 of the *Civil Resolution Tribunal Act* (CRTA). The applicable CRT rules are those in place at the time the Dispute Notice is issued.
- 4. The CRT will make a binding decision without the participation of the respondent(s). The CRT will send the parties a copy of the final decision and order.
- 5. Where permitted under the CRTA, in resolving this dispute the CRT may order a party to do or stop doing something, pay money or make an order that includes any terms or conditions the tribunal considers appropriate.

Decision:

6. The applicants say that the respondent overcharged them for moving services in the amount of \$1,989.70. They say that the respondent overcharged them in weight for the move and



has refused to provide them with the weight records. Liability is assumed, and as the respondent has not participated in the dispute, I find the respondent overcharged the applicants. I find the respondent must refund the applicants \$1,989.70

- 7. The applicants also claim \$930 in lost wages and \$1,580.30 for property damage and missing belongings. While liability is assumed in default decisions, I must still assess the value of any non-debt claims. I find the applicants' claims for lost wages, property damage, and missing belongings are non-debt claims.
- 8. For the applicants' wage loss claim, they claim 13 hours of wage loss at \$60 per hour and 5 hours of wage loss at \$30 per hour. However, the applicants have provided no evidence showing that, first, they missed work, and second, what their hourly wages were. I find that the applicants have failed to prove this aspect of their claim. For these reasons, I dismiss their wage loss claim.
- 9. For the applicants' property damage and missing belongings claims, they seek \$1,580.30 in repair and replacement costs from the respondent. Based on the photos provided, I find that many of the applicants' belongings were damaged, with some so heavily damaged or destroyed that it would require total replacement. I find that the heavily damaged items to be a coffee table and an executive desk chair, and the destroyed item to be a dresser. I also accept the undisputed belongings that went missing, which were a step ladder and a picture mat matting. I find that the heavily damaged belongings and the missing items all must be replaced. Based on the receipts and replacement cost estimates provided by the applicants, which I accept, I find the total amount for replacement costs likely exceeds the claimed amount. So, I order the respondent to pay the applicants the claimed \$1,580.30 for damaged and missing belongings.
- 10. I find the respondent must pay the applicants the monetary amounts as set out in the preceding pages. This amount is payable immediately.
- 11. I find the applicants are entitled any applicable post-judgement interest, which is not included as part of the "total order" amount.



CRT ORDER

- 12. In accordance with the CRTA and the CRT'S rules, further to the decision set out above, I order the respondent to immediately pay the applicants the monetary orders set out in the preceding pages. The applicants are entitled to post-judgment interest.
- 13. The applicants waived their claim for pre-judgment interest, so I award none.
- 14. As set out in 58.1(3) of the CRTA, a party may only enforce this order if the time for making a notice of objection has passed and a Notice of Objection has not been filed. The party in default has no right to make a Notice of Objection, as set out in section 56.1(2.1) of the CRTA.
- 15. Orders for financial compensation or the return of personal property can be enforced through the Provincial Court of British Columbia, so long as the principal value is within its jurisdiction under the *Small Claims Act* (currently \$35,000). The applicant(s) can enforce this final decision by filing a validated copy of this order in the Provincial Court of British Columbia. Once filed, a CRT order has the same force and effect as an order of the Provincial Court of British Columbia.
